

# How an invisible virus changed the world

*After having written about 26 articles about corona, the first of which dates from 2012, I resolved to remain silent about this. However, now that so much news about this is appearing in the media with all kinds of conflicting reports and the fact that I have now been removed from LinkedIn for the second time because I am critical about the cabinet policy, I will once again give my opinion and indicate what I have difficulty with. There will be all kinds of counter-arguments, but so be it!*

My first article on the coronavirus was dated February 3, 2012 and was titled SARS-CoV virus. My closing word was as follows:

“Coronaviruses are like weeds in your garden. If you don't eradicate this to the last fiber, it will come back. The danger of coronaviruses, however, is that they are constantly mutating. If it is thought to have been eliminated and some particles remain, then it can resurface in full force, often mutated.

Now it is usually the case that when the crisis is over, the development of a vaccine is put on the back burner. Although I do see a danger in vaccinating people who test positive. The virus will resist the vaccine and mutate. However, the vaccinated individuals remain contagious to others!

If this virus rears its head somewhere, it will affect many people worldwide, partly due to frequent travel. Next time, this contagious virus could strike very hard and potentially lead to a pandemic. The result: no (preventive) vaccine, a major shortage of antiviral (auxiliary) drugs and problems with the care capacity in the event of very serious infections! The consequences will be disastrous with many casualties!”

## Immune system

With good health and a correct lifestyle, people have an excellent functioning immune system. This system protects the body from disease and consists of two parts:

1. **Innate Immunity.** First to detect viruses, bacteria, parasites and toxins and first to detect wounds. It activates cells to attack and destroy or repair them and informs and modulates the adaptive immune response.
2. **adaptive, or acquired, immunity.** This is the second and specific line of defense. After recognizing the invader, the cells can multiply and fight off, leading to recovery from disease and protection against recurrence.

The innate immunity, which is therefore also very strong in children, is also able to eliminate the virus. Innate immunity consists of, among other things, innate antibodies. These are substances that one receives from birth. Those innate antibodies are able to neutralize a multitude of variants of viruses, in fact all coronaviruses! It is therefore of great importance that the immune system works optimally and is not suppressed. This 'suppression' can be done, among other things, by having a bad lifestyle or by vaccinating!

## Vaccine

A vaccine is a medicine that includes killed or weakened pathogens to which the adaptive immune system responds. The influenza (flu) vaccine contains parts of several types of dead influenza virus.

In the event of infection, the immune system will recognize and fight this pathogen. The person who has received the vaccine will, if possible, become less ill if infected with the virus. One will certainly not become virus-free, because one can carry the virus and infect others.

The vaccines used against the coronavirus should not actually be called vaccines. The 'vaccine' does not consist, as usual, of a dead or weakened pathogen, but of a 'messenger' RNA, which gives instructions to the cell. The cell is programmed, as it were, to produce a specific protein. As a result, the body produces antibodies against the virus, causing the immune system to attack the virus.

All approved corona vaccines have been provisionally licensed. This means that the vaccine developers are obliged to continue to supply information to, among others, the European medicines agency EMA for the next two years, such as from the current phase 3 study, but also from additional studies.

### **Children**

By vaccinating children, which suppresses their innate antibodies, we put these antibodies aside, which are actually intended to make other viruses that cause childhood diseases ineffective. So we are going to make these children more sensitive, not only to COVID-19, because resistance will develop anyway, but also to other respiratory viruses, to which they are normally resistant in a natural way. Another very worrisome point is that the immune system can no longer recognize its own components that protect against autoimmune diseases.

### **Booster shot**

The 'trained' natural antibodies will be severely hindered by the vaccinal antibodies, because they compete with each other. The vaccinal antibodies become less effective in the long run. But because these have suppressed the naturally developed antibodies, they will no longer work (well). As I mentioned above, the mRNA 'programs' the cell. This will remain in your system. As the policy makers have already indicated, the vaccines are only valid for a few months. It has even been indicated that four vaccinations per year are being considered. You get that by replacing the natural immune system with a modified system.

### **Government policy**

The Dutch Government is advised by the Outbreak Management Team (OMT), the Health Council, the EU and developments in the pharmaceutical industry. I am therefore immensely annoyed that it continues to call to vaccination as soon as possible, or to take the booster shot. 'The field' and all messages from abroad are not listened to. If the contamination increases (omicron), but hospital and ICU admissions decrease, the cabinet will insist on the booster shot and possibly a lockdown. Pure scare tactics! And what is also distressing, that all contradiction is ignored or suppressed, such as the doctors' collective, in which thousands of specialists participate, which, like me, is simply removed from LinkedIn. This smells like dictatorial policies. If one speaks loudly about violation of human rights, violation of privacy, etc, how can one consider making vaccination mandatory and, if you don't, you will be excluded from a large part of society. Covered by the OMT, the cabinet will continue to pursue their vision, even if this is wrong. Should unexplained diseases occur or the average number of deaths within the population rise, this will not be a reason for the government to change its course.

### **My conclusion**

Man is a very complex self-sufficient being, which develops and sustains itself. If you intervene without knowing the further consequences, caution is advised.

Now that half the Greek alphabet of variants have been reviewed, we have arrived at the omicron variant, more contagious than previous variants, but less serious. As far as is known, no patient has died from this variant. We must be happy with this variant, nature restores itself, a gift from heaven! The omicron variant is currently dominant in the Netherlands and will naturally, due to its high contamination, expel the other variants and increase the immunity of the population, without serious consequences! If this is countered with vaccination, the virus will defend itself and new mutations will take place and what will we get?

**Finally**

I am definitely not against vaccination! I am against the obligation of vaccination that is imposed by the cabinet with all the restrictions that follow if you do not take it. Everyone has the civil right to decide for themselves, just like the annual flu shot. This article is for background information only.
